Responsibilities

- The mission of the CHP is to provide the highest level of Safety, Service, and Security. This includes not only patrolling the roadways but protecting the state infrastructure. The CHP also provides security for the Governor, state constitutional officers, State Supreme Court Justices, Appellate Courts, and various dignitaries.
- The Department's primary jurisdiction is the unincorporated roadways and all freeway systems
- The CHP San Diego Area is responsible for providing law enforcement service for twelve freeways encompassing the cities of San Diego, Chula Vista, and National City.






Responsibilities (Continued)

- CHP San Diego Area responds to calls of incidents/service on the Coronado Bay Bridge, and non-federal incidents/crimes at the San Ysidro and Otay Mesa ports of entry.
- On an average day, the CHP Border Communications Center receives over 1,000 calls for service and/or emergencies for San Diego Area. Call volume significantly increases on days of inclement weather.

Crash Statistics

- 2020: 74 crashes 42 PDO (8 DUI involved), 32 injury crashes (3 DUI involved)
- 2021: 58 crashes 21 PDO (6 DUI involved), 37 injury crashes (9 DUI involved)

Responsibilities

- The mission of the San Diego County Sheriff's Department is to provide the highest quality public safety service to everyone in San Diego County.
